Notes: Fiscal Year 2015 totals were not available at the time of this analysis. All data was taken from the transparent.utah.gov website on March 9, 2015. Gross compensation equals the total cost of salaries plus benefits. Since Eagle Mountain no longer provides job title info on the state's transparency website some of the titles in this doc may not be current. The city's fiscal year runs from July 1 to June 30 of the following year. Obvious part time employees and employees who did not work for all of FY 2012, FY 2013 and FY 2014 were excluded from this analysis. Most of the food and clothing purchases made by the city were not disclosed on the transparent.utah.gov website as required by law.
